All components are labeled with a "use by" date, printed at the bottom right corner of every package. Following is the label design for all Phoscrete MPC products. **Always match the color of the bag and jug!**

Shelf Life (when properly stored)

Product / Component	Shelf Life	Storage Conditions
Phoscrete Dry Mix [and admixtures]	2 years	indoors, low humidity
Phoscrete Activator	1 year	minimize temperature swings



Use of Expired Material?

Phoscrete **STRONGLY** advises against installing expired material, material improperly stored, or material opened or damaged. If you cannot avoid installing a questionable material, first mix a full kit in your shop and observe mixing properties, time of set, and maximum temperature to verify the material is consistent with fresh product.

Disposal

Hardened Phoscrete concrete and Dry Mix powder can be disposed in any dumpster or landfill. Formula 1 Liquid Activator must be neutralized before disposing.
